## Introduction

PG Pleasure Boats Ltd t/a Grove Ferry River Trips gather and use personal information from customers, suppliers, business contacts, sub-contractors and other people the organisation has a relationship with or may need to contact.

This policy describes how we protect your privacy and how you can control how we use your personal information, how it is collected, handled and stored to comply with the law.

## What information is collected and why?

In general, you can browse the websites without disclosing any information about yourself at all.

When you provide your information to us directly via our website, by email, over the phone or face to face we only ask you to supply information that we need in order to provide the service you have requested. We will normally ask you to provide us with your name, address, email address, phone number and criteria specific to your enquiry.

However, if you do business with us we may also ask for further information about you or your company including finance details.

You may also provide your information to us via another website for example Facebook or Twitter.

The data collected is only used by PG Pleasure Boats Ltd and it's sub-contractors to manage bookings, occasionally to keep you informed and updated, to improve our website, and for the safe operation of the Company.

The information is NOT shared, sold or in any way provided to any third parties.

## How do we protect your personal details?

We take our obligations to keep your personal data safe and secure very seriously, we have strict procedures governing the storage and disclosure of personal details to prevent unauthorised access and misuse.

Bookings are removed from the online database within 2 weeks of the booking date and are then held in a secure database for a further year before being deleted or anonymised.

Business and safety contacts are available to Directors and sub-contractors in a secure online database.

In certain circumstances we have a statutory obligation to keep personal data for a set period of time for example financial information (normally 6-7 years) for financial auditing purposes.



## Access to your personal information

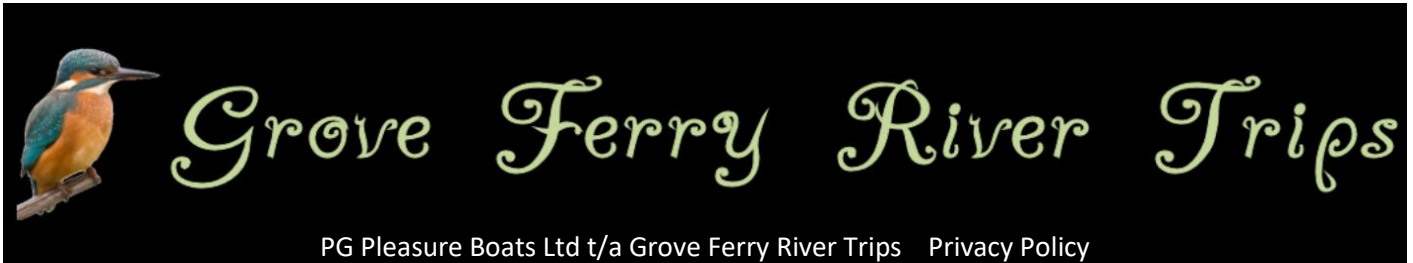
These cookies collect information about how visitors use our website, for instance which pages visitors go to most often. The information collected is anonymous and is only used to improve the way our website works.
